The Colorado State Thespian Society presents this award to recognize high school and district administrators who have encouraged and promoted educational theatre. Administrators from all schools or school districts affiliated with The Colorado State Thespian Society are eligible for the Administrator's Award. Previous award recipients may not apply. If there is any question about the eligibility of an administrator, contact the Colorado State Thespians.

Sponsors of active Thespian troupes may nominate a department, building, or district level administrator for the award. Sponsors are requested to complete the nomination form in full. Please type or print legibly; use black ink only. Forms must be received by **November 1<sup>st</sup> of each calendar year.**

An advisory committee of the CITS will choose the finalists from all the nomination forms received by the deadline date. From the selection of finalists, the Colorado State Thespians will make the final selection. There will be no discrimination by size of schools.

The CITS will notify those troupe sponsors whose nominations were selected as recipient(s). The administrator and/or a representative of the administrator's school will be requested to attend the award presentation at Colorado State Thespian Conference. The award will be presented before the entire sponsor delegation at the Colorado State Thespian Conference.
